

Terms of Service

These Terms of Service ("Terms") govern your use of the Reel Legends platform operated by Pipewolf Solutions LLC ("we," "us," or "our"). By creating an account or using the Service you agree to these Terms. If you do not agree, do not use the Service.

1. Eligibility

You must be at least 13 years of age to use the Service. By using the Service you represent that you meet this requirement. Users under 18 must have parental or guardian consent.

2. Accounts

- You are responsible for maintaining the security of your account credentials.
- You must provide accurate and complete information during registration.
- You may not share your account with others or create accounts on behalf of others without authorization.
- We reserve the right to suspend or terminate accounts that violate these Terms.

3. Subscriptions and Payments

Reel Legends offers paid subscription tiers processed through PayPal:

- **Angler Pro:** \$20.00/year
- **Pro/Guide:** \$50.00/year
- **Tournament Manager:** \$250.00/year plus \$1.00 per registered player per tournament billed after tournament close.

All payments are non-refundable unless required by applicable law. Subscriptions renew annually. You may cancel or manage your subscription from your Account Settings page.

4. Tournament Entry Fees

Some tournaments charge an entry fee collected through PayPal at the time of joining. Physical tournament registration fees are handled outside the platform directly between the player and the tournament director. Reel Legends is not responsible for disputes arising from fees collected outside the platform.

5. User Content

You retain ownership of content you submit including catch photos and profile photos. By submitting content you grant us a non-exclusive, royalty-free license to display and use that content within the Service. You represent that you have the right to submit all content you provide and that it does not violate any third-party

rights.

6. Prohibited Conduct

You agree not to:

- Submit falsified, altered, or fraudulent catch photos or data.
- Manipulate GPS or EXIF data in submitted photos.
- Harass, threaten, or abuse other users.
- Attempt to gain unauthorized access to any part of the Service.
- Use the Service for any unlawful purpose.
- Create multiple accounts to circumvent bans or restrictions.
- Submit catches of fish caught outside designated tournament boundaries.

7. Tournament Withdrawals

Withdrawing from a tournament after joining earns a Rubber Duck badge on your account. After three withdrawals your account may be restricted from certain tournaments. There may be financial penalties for withdrawing from paid tournaments as specified in individual tournament rules.

8. Termination

We may suspend or terminate your account at our discretion for violations of these Terms, fraudulent activity, or conduct harmful to other users or the platform. You may delete your account at any time from your Account Settings.

9. Disclaimer of Warranties

The Service is provided "as is" without warranties of any kind, express or implied. We do not warrant that the Service will be uninterrupted, error-free, or free of viruses or other harmful components.

10. Limitation of Liability

To the fullest extent permitted by law, Pipewolf Solutions LLC shall not be liable for any indirect, incidental, special, or consequential damages arising from your use of the Service, including but not limited to lost profits, lost data, or personal injury.

11. Governing Law

These Terms are governed by the laws of the State of Texas, USA, without regard to conflict of law principles. Any disputes shall be resolved in the courts of Texas.

We reserve the right to modify these Terms at any time. Continued use of the Service after changes constitutes acceptance of the new Terms.
