

Acceptable Use Policy

This Acceptable Use Policy ("AUP") defines the rules for acceptable use of the Reel Legends platform. By using the Service you agree to comply with this policy. Violations may result in suspension or permanent termination of your account.

1. Permitted Use

You may use Reel Legends to:

- Create and manage a fishing profile and player card.
- Join and participate in fishing tournaments.
- Submit legitimate catch photos taken during tournaments or solo fishing.
- Create and manage fishing tournaments as permitted by your subscription tier.
- Communicate with other users through the platform's built-in features.
- Showcase your fishing guide business (Pro/Guide subscribers).

2. Prohibited Use

You may not use Reel Legends to:

- Submit fraudulent, falsified, altered, or stolen catch photos.
- Manipulate or alter GPS coordinates or EXIF data in submitted photos.
- Impersonate another person or entity.
- Harass, threaten, intimidate, or abuse other users.
- Post obscene, offensive, or inappropriate content in any profile, tournament, or catch description.
- Use the platform for any commercial purpose not authorized by Reel Legends.
- Attempt to gain unauthorized access to any account, system, or network.
- Introduce malware, viruses, or malicious code.
- Scrape, crawl, or systematically extract data from the platform.
- Create multiple accounts to evade bans, restrictions, or fees.
- Use automated bots or scripts to interact with the Service.
- Engage in any activity that disrupts or interferes with the Service.

3. Catch Submission Rules

- All catch photos must be taken at the time of catch using your own device.

- Fish must be photographed in water on a measuring board per tournament rules.
- Submitting the same fish in multiple catches is strictly prohibited.
- Submitting photos of dead fish is prohibited.
- Catches must be made within the designated tournament boundary.

4. Content Standards

All content submitted to Reel Legends including profile photos, catch photos, and tournament descriptions must:

- Be accurate and not misleading.
- Not contain nudity, sexually explicit material, or graphic violence.
- Not infringe on any third-party copyright, trademark, or intellectual property rights.
- Not contain personal information of others without their consent.

5. Tournament Conduct

- Tournament creators must enforce their stated rules fairly and consistently.
- Tournament Managers must use the platform tools in good faith for legitimate tournaments.
- Colluding with other players to manipulate tournament results is prohibited.

6. Enforcement

We reserve the right to remove any content that violates this policy and to suspend or terminate any account without notice for serious violations. We may report illegal activity to appropriate authorities.
